Thanks for your time earlier.

On the basis that our work scope is carrying out a desk top review of the INFRACO Contract to report to CEC on (i) options for a tie exit and consequent exit liabilities (i.e. in scope rather than quantum) and (ii) ability to reduce the cost of the contract by instructing a change to downsize the project and consequent liabilities (again in scope rather than quantum), I would estimate that our fee to prepare the report will be around £10,500 exclusive of VAT and any outlays.

This figure is based on "tie rates" (ie £200 per hour for a partner (me) and £150 for a Senior Associate (for Construction input)). We have allowed for 5 days work to carry out the review, produce the report and meet with you to run through the report. To the extent there is any follow up work or queries, it would be charged at tie rates. We could firm up on an estimate for any required follow up work at the time depending on the scale of activity involved.

We'd be aiming to get you the report in draft (albeit substantively complete) in a week's time with a view to meeting up towards the end of the w/e 12 Feb.

I hope this is acceptable but if you have any queries please just give me a call.
