1 Client Relations

1.1 tie

Having set a target of 29 March for the award of the Infraco Contract *tie* has now had to acknowledge that with negotiations continuing the target cannot be met. A revised date of 15 April has now been advised to me by Jim McEwan.

Novation meetings continued with *tie* and BBS on Wednesday and Thursday this week and Friday was taken up with a 7 hour programme review meeting aimed at eradicating points of conflict between the SDS and BBS programmes. This meeting, chaired by Steven Bell for *tie* made significant progress and I am now more confident that a schedule of programme milestones which is acceptable to PB can be produced for inclusion in the Novation Agreement. The programme review only touched on the topic of timescales required to accommodate design revisions suggested by the BBS Offer so it remains the case that *tie* has a price on the table which assumes approximately £12m of value engineering improvements will be delivered and a construction programme which does not reflect the design effort required to deliver those improvements. *tie* appears comfortable with this state of affairs and has suggested that changes will be instructed on day one of the Infraco contract to address the imbalance. I do not believe the major stakeholders, including CEC are aware of the position and we must ensure that the Novation Agreement is worded such that it protects PB from any accusations of deception which could be levelled at *tie* in future.

I have continued to work closely with Jim McEwan this week to ensure his appreciation of PB's position on the variety of technical and commercial detail currently being addressed ahead of novation. My next regular meeting with Willie Gallagher to review longer term topics is now scheduled for Wednesday next week.


